He earned his Master's degree and PhD degree from the Faculty of Economics in Belgrade in 1987 and 1993, respectively. He is a member of the editorial boards of the journals Panoeconomicus and Journal of Business and Economics. He has completed professional development abroad (Universities of Bochum, Frankfurt, Graz, Europa institut, Saarbruecken). Within the IVP program he visited a number of universities in the US. Since 2011, he has been visiting professor at Al-farabi Kazakh National University. He is the founder and first director of the Centre for Multidisciplinary Studies and Scientific Research at the University of Nis. One of the most important activities was improvement of Master Program European Studies. Professor Stojanovic served as Vice-Dean of the Faculty of Economics in Nis, a member of the first Serbian Accreditation Commission and a referee for institutions and study programs that are accredited in higher education. He has been actively participating in the reform of the University and in 3 TEMPUS projects. He is President of the Nis Association of Economists, a member on the Executive Committee and presidential board of the Serbian Association of Economists. He is active in the program of the European Agency for Reconstruction. Stojanovic is a member of the Serbian Scientific Society of Economists. During the first year of carrying out the Project, all necessary assumptions for the beginning of teaching activities will be provided. In the scope of realization of the objects are to be defined syllabi, teaching methodologies, teaching materials and web site. Good image that the EU modules would get will be relatively easy finding target groups on regional level. External practice are crucial ones in the sense of permanent improvement of teaching and ensuring higher quality of all teaching activities. Taking into account that ideas on similar activities appear, then after the Project realization, cooperation with EU partners should be kept on and further improved, so that would keep and improve the quality.

The program prepares the fellows for a career in European administration, business or politics.
